

## HFS Federal Credit Union Member Appreciation Sweepstakes Official Rules

# No Purchase or Payment Necessary to Enter Or Win. A Purchase or Payment Will Not Increase Your Odds of Winning.

#### 1. Sweepstakes Sponsor

- a. This sweepstakes is sponsored by HFS Federal Credit Union. This promotion is not sponsored, endorsed or administered by, or associated with, Apple Inc. By participating in this sweepstakes, you agree to abide by all sweepstakes rules and regulations.

## 2. Eligibility

- a. Must be 13 years of age or older and either (i) a legal resident of the island of Hawai'i, or (ii) a member of HFS Federal Credit Union, to participate. Limit one entry per person. No purchase or payment of any kind is necessary to enter or win. Individuals under the age of 13 may not enter or submit information to this sweepstakes.
- Odds of winning are dependent on number of participants. For example, with 6 prizes available, the odds of winning will be 6 out of 100 if there are 100 entries.
   HFS Federal Credit Union officials, employees, and their immediate family and household members are not eligible to win. Void where prohibited.
- c. This sweepstakes is subject to the terms and conditions herein and all applicable federal, state, and local laws and regulations. Void where prohibited.

## 3. Sweepstakes Entry Period

This sweepstakes will begin on 2/22/2021 at 8:30 am HST and will end on 2/28/2021 at 11:59 pm HST (the "Sweepstakes Period"). No entries will be accepted before or after the Sweepstakes Period.

#### 4. How to Enter

- a. There is no action necessary for current HFS Federal Credit Union members to enter the Sweepstakes. All members ages 13 and older of HFS Federal Credit Union and those who become members by the end of the Sweepstakes Period will be entered. Becoming an HFS Federal Credit Union member is not required to enter or win, and eligible members are not allowed to submit additional entries by mail.
- b. Becoming an HFS Federal Credit Union members is not required to enter or win. To enter the sweepstakes without becoming a member, send your name, phone number and mailing address to 632 Kinoole Street, Hilo, Hawaii 96720 postmarked no later than February 28, 2021.

#### 5. Selection Process

- a. All eligible entries throughout the Sweepstakes Period will be entered into a database. The Winners (defined below) will be chosen at random from the eligible entries on 3/5/2021. The Winners will be notified by phone, mail, or email by 3/8/2021.
- b. Each entrant is responsible for monitoring for prize notification and receipt or other communications related to this sweepstakes. If a Winner fails to claim his or her Prize by 3/19/2021, the Winner shall forfeit the prize and an alternate Winner will be randomly selected from the remaining eligible entries.
- c. Upon the request of HFS Federal Credit Union, the Winners may be required to fill out a Release, Waiver and Indemnification Form.

#### 6. Prize

- a. Six people, chosen at random from the eligible entries will be the winners (individually a "Winner" and collectively the "Winners") and will each receive one Apple® iPad (the "Prize"). Each Prize is valued at \$328.26 and the Total Prize Value for all 6 Prizes is \$1,969.56.
- b. The Prize is not exchangeable or transferable to another person.
- c. ELIGIBILITY FOR MINOR TEENS AGES 13-17. To enter the Sweepstakes, you must have the permission of your parent or legal guardian ("Parent") prior to entering and be the age of thirteen (13) or older at the time of entry (each a "Teen Entrant", collectively the "Teen Entrants"). Each Teen Entrant at the time of the sweepstakes entry must have the permission of his/her Parent prior to entry and such entry shall be deemed submitted by the Parent and shall be treated as if the Parent had made such entry and if chosen as a Winner, and the Prize will be awarded in the name of his/her Parent.
