



HFS Federal Credit Union ICU Day Zogo Sweepstakes Official Rules

No Purchase or Payment Necessary to Enter Or Win.

A Purchase or Payment Will Not Increase Your Odds of Winning.

1. Sweepstakes Sponsor

2. Eligibility
 - a. Must be 13 years of age or older and either (i) a legal resident of the island of Hawai'i, or (ii) a member of HFS Federal Credit Union, to participate. Limit one entry per person. No purchase or payment of any kind is necessary to enter or win. Individuals under the age of 13 may not enter or submit information to this sweepstakes.
 - b. Odds of winning are dependent on number of participants. For example, with 3 prizes available, the odds of winning the first prize will be 1 out of 100 if there are 100 entries, 1 out of 99 on the second prize, and 1 out of 98 on the third prize. HFS Federal Credit Union officials, employees, and their immediate family and household members are not eligible to win. Void where prohibited.
 - c. This sweepstakes is subject to the terms and conditions herein and all applicable federal, state, and local laws and regulations. Void where prohibited.
3. Sweepstakes Entry Period

This sweepstakes will begin on October 1, 2021 at 8:30 am HST and will end on October 31, 2021 at 11:59 pm HST (the "Sweepstakes Period"). No entries will be accepted before or after the Sweepstakes Period.
4. How to Enter
 - a. If you own or have access to a mobile phone, enter the sweepstakes during the Sweepstakes Period by visiting your phone's App Store to download the Zogo App. Use the access code "**HFSFCU**" to create your account.
 - b. If you do not own a mobile phone and/or desire to enter the sweepstakes during the Sweepstakes Period without downloading the Zogo App, send your name, phone number and mailing address to 632 Kinoole Street, Hilo, Hawaii 96720 postmarked no later than October 31, 2021.

5. Selection Process

- a. All eligible entries throughout the Sweepstakes Period will be entered into a database. The Winners (defined below) will be chosen at random from the eligible entries on November 5, 2021. The Winners will be notified by phone, mail, or email by November 12, 2021.
- b. Each entrant is responsible for monitoring for prize notification and receipt or other communications related to this sweepstakes. If a Winner fails to complete the required documentation acknowledging their Prize by November 19, 2021, the Winner shall forfeit the prize and an alternate Winner will be randomly selected from the remaining eligible entries.
- c. Upon the request of HFS Federal Credit Union, the parents or guardians of a Winner who is a minor (under the age of 18) will be required to fill out a Release, Waiver and Indemnification Form.
- d. **Prizes may not be awarded if an insufficient number of eligible entries are received by October 31, 2021 at 11:59 pm HST.**

6. Prize

- a. Three people, chosen at random from the eligible entries, will be the winners (the "Winners") and will receive a JBL Headset (the "Prize"). The Prize is valued at \$136.12. Total value of Prizes is \$408.36.
 - b. The Prize is not exchangeable or transferable to another person.
 - c. **ELIGIBILITY FOR MINOR TEENS AGES 13-17.** To enter the Sweepstakes, you must have the permission of your parent or legal guardian ("Parent") prior to entering and be the age of thirteen (13) or older at the time of entry (each a "Teen Entrant", collectively the "Teen Entrants"). Each Teen Entrant at the time of the sweepstakes entry must have the permission of his/her Parent prior to entry and such entry shall be deemed submitted by the Parent and shall be treated as if the Parent had made such entry and if chosen as a Winner, and the Prize will be awarded in the name of his/her Parent.  - d. Winners must be able to pick up their Prize at one of our 6 HFS branch locations. Failure to do so by 5:00pm HST on November 19, 2021 will forfeit the Prize. If the Prize is forfeited by the first Winner, an alternative Winner will be selected at random from the remaining eligible entries. If a Winner is age 13-17, he/she must be accompanied by a parent or legal guardian.
