

## HFS Federal Credit Union 2023 Youth Month Coin Bank Contest Official Rules

## No Purchase or Payment is Necessary to Enter or Win. A Purchase or Payment Will Not Increase Your Odds of Winning.

- 1. Contest Sponsor
  - a. This contest is sponsored by HFS Federal Credit Union. By participating in this contest, you agree to abide by all contest rules and regulations.

- 2. Eligibility
  - a. Must be 17 years of age or younger and either (i) a legal resident of the island of Hawai'i, or (ii) a member of HFS Federal Credit Union, to participate. Limit one entry per person. No purchase or payment of any kind is necessary to enter or win. Individuals over the age of 17 may not enter or submit information to this contest
  - b. Odds of winning are dependent on the number of participants. For example, with 1 prize available, the odds of winning the prize will be 1 out of 100 if there are 100 entries. HFS Federal Credit Union officials, employees, and their immediate family and household members are not eligible to win. Void where prohibited.
  - c. This contest is subject to the terms and conditions herein and all applicable federal, state, and local laws and regulations. Void where prohibited.

## 3. Contest Entry Period

This contest will begin on April 1, 2023, at 8:30 am HST and will end on April 29, 2023, at 11:59 pm HST (the "Contest Period"). No entries will be accepted before or after the Contest Period.

- 4. How to Enter
  - a. Visit any one of our 6 branch locations, island-wide.
  - b. Locate the coin bank in the branch and submit an entry slip with the keiki's name, and the address and phone number of a parent/guardian along with a guess of how much money is contained in the coin bank.
  - c. Submit the entry slip, and that's it! The closest guess, without going over, at each branch will win the coin bank and all the money contained inside of it.

- 5. Selection Process
  - a. The closest guess, without going over, at each of the 6 branch locations will be the Winners. Winning entries will be chosen based on the following criteria:
    - i. Adherence to contest guidelines
    - ii. Completion of Entry Form
    - iii. Guess of Monetary Amount

The winners will be chosen on May 5, 2023 and notified no later than May 15, 2023.

- b. Each entrant is responsible for monitoring for prize notification and receipt or other communications related to this contest. If a Winner fails to complete the required documentation acknowledging their Prize by May 26, 2023, the Winner shall forfeit the prize and an alternate Winner will be selected based on the next closest guess.
- c. Upon the request of HFS Federal Credit Union, the parents or guardians of a Winner who is a minor (under the age of 18) will be required to fill out a Release, Waiver, and Indemnification Form.
- d. Prizes may not be awarded if an insufficient number of eligible entries are received by April 29, 2023, at 11:59 pm HST.
- 6. Prize
  - a. Six people, chosen based on the contest guidelines, will be the winners (the "Winners") and will receive a coin bank and the money contained in it (the "Prize"). The Prize is valued at approximately \$636.24 in total.
  - b. The Prize is not exchangeable or transferable to another person.
  - c. ELIGIBILITY FOR MINOR TEENS AGES 17 AND UNDER. To enter the Contest, you must have the permission of your parent or legal guardian ("Parent") prior to entering and be the age of seventeen (17) or younger at the time of entry (each a "Minor Entrant", collectively the "Minor Entrants"). Each Minor Entrant at the time of the contest entry must have the permission of his/her Parent prior to entry and such entry shall be deemed submitted by the Parent and shall be treated as if the Parent had made such entry and if chosen as a Winner, and the Prize will be awarded in the name of his/her Parent. Each Minor Entrant's parent or legal guardian must agree to these Official Rules. If the parent or legal guardian of a Minor Entrant does not agree to these Official Rules, the Minor Entrant is not eligible to participate in the Contest or to win a Prize. The parent or legal guardian of each Minor Entrant agrees that the Minor Entrant's submission of an entry and his/her signature on the Prize acknowledgment forms constitutes his/her agreement to enter into the Contest and to the terms and conditions in these Official Rules. If the Winner is a Minor Entrant, written parental consent will be required to redeem the Prize.
- 7. The Winners are solely responsible for all income, federal, state, and local taxes as well as any other costs and expenses associated with the Prize acceptance.
